Minutes of the 208th Online Meeting of the Fees Regulating Authority (constituted under section 11(2)(3)(4) of the Maharashtra Unaided Private Professional Educational Institutions (Regulation Admissions and Fees) Act, 2015) held on Tuesday at 11:00 a.m. is conducted on Zoom Application.

Since regular posts of Chartered Accountant and Cost Accountant are vacant, Mr. Sanjay Pansse, CA, and Ex-Member of this Authority and Mrs. Vaishali Bapat, Cost Accountant from the panel of CA, have been invited to assist the Authority.

Item No. 1: Extension of time for submission of fees proposals A.Y. 2021-22.

Read office note and the list of the colleges (marked A) who have asked for more time to submit fees proposals. The main reason assigned is the situation created due to the pandemic. Their balance sheets and audit reports are not ready.

Up till now twice the time to submit the fees proposal has been extended. As a last chance, the colleges who have not submitted fees proposals shall submit them

on or before 20th January 2021. They should note that no further time will be granted. In the event, they fail to submit fees proposals on or before 20th January 2021; the law will take its course.

Item No. 2: To consider and decide fee structure of AY 2019-20 and AY 2020-21 - JIU's Mother Hawa College of Nursing, Jaina.

Heard Saphadidevi N., I/c Principal and Mohamad Anis, Accountant.

A number of flaws appearing in the balance-sheet and faculty details have been brought to their notice. The staff at sr. no. 4, Vandal Basangouda although joined on 1/4/2019 (As per joining date mentioned in the proposal) his salary of Rs. 5,40,000/- has been claimed in the F.Y. 2018-19. Mr. Ekanath Gulane, Priyanka, Vairal Ramashwar all joined in March, 2019. Despite, this it is shown that they have been paid Rs. 1,80,000/- Rs. 1,80,000/- and Rs. 2,16,000/- each respectively. In fact, their monthly salaries are Rs. 15,000/-, Rs. 15,000/- and Rs. 18,000/- each respectively. The number of staff appear to have been joined in the mid-session. The balance-sheet reveals book entries between trust and the college. It is admitted that the college did not have a bank account till the year 2019. In view of this the claim, that salaries paid through the bank, becomes doubtful.

The college has realized the shortcomings/ flaws in their proposal. Vide letter submitted and marked "X" the college has proposed fees of Rs. 40,000/-. In the communication dated 15/10/2020 it has been clarified that they collected a fee of Rs. 32,500/- from the students in batch A.Y. 2019-20. We are of the view that the fee proposed is minimum required to conduct B.Sc. nursing course.

In view of the above the fees for B.Sc. Nursing: **A.Y. 2019-20 Rs. 32,500/-**
A.Y. 2020-21 Rs. 40,000/-

Item No. 3: To consider the letter dated 17/12/2020 received from Ramesh Phirodia College of Architecture, Ahmednagar regarding finalisation of fee structure for A.Y. 2018-19.

Heard Dr. Bipin Bonde, Principal.

After explaining the fact situation to him, he has agreed that from the students in 2018-19 batch, the college voluntarily collected fees of Rs. 80,000/-. Now they

have agreed to retain the same fee for the students in batch of 2018-19 till they complete the entire course. In this regard, the college has sent a letter dated 5/1/2021. It is further stated that their communication dated 17/12/2020 shall stand withdrawn.

In view of the above, the matter stands disposed of.

Item No. 4: To consider letter dated 17/12/2020 received from the College of Agriculture, Donagarshelki Tanda, Udgir, Dist. Latur regarding fixation of fees for A.Y. 2021-22.

The college had submitted a fees proposal for the A.Y. 2019-20. The FRA approved the fees as Rs. 75,000/-. The college opted to retain the same fee for the A.Y. 2020-21. The problem faced by the college in submitting fees proposal for A.Y. 2021-22, as stated by them, is their internal disputes which resulted in the court cases.

All the colleges who have not submitted fees proposals till date, have been given more time till 20th January 2021 to submit their fees proposals. Therefore, the college is advised to take the necessary steps to submit the fees proposals within the time extended.

Item No. 5: Any other matter with the permission of the chair,



The colleges in the list marked "X" had submitted fees proposals for the A.Y. 2019-20. Accordingly, the FRA approved reasonable fee structures. These colleges opted for no upward revision for the AY 2020-21. Therefore, the fee structures approved for the AY 2019-20 were allowed to be retained for the next academic year, i.e. 2020-21.

On behalf of the colleges, it is pointed out that the unprecedented COVID-19 pandemic has wrought havoc on all the strata of society. The physical immobilisation and disability caused by pandemics, followed by lockdown imposed by the government have their own adverse impact. All the normal activities came to a standstill. In this peculiar situation, they are not ready with the balance sheet, audit report. Further, they do not seek upward revision on humanitarian grounds. They do not want to put an additional burden on parents whose wards are desirous of seeking admission in their colleges in the AY 2021-22.

We have perused the list of the colleges and had a glance at the fee structure approved for AY 2019-20. The approved fee structures appear reasonable. In this peculiar situation, the colleges in the list "X" are allowed to retain, for the A.Y. 2021-22, the fee structure which was approved for the AY 2019-20.
